HOW TO PAY YOUR MEMBERSHIP FEES FOR 2021

Due to the disruption of activities in the past year, members who paid a full membership fee in 2020 are offered a reduced fee of \$40.00 for 2021. Eligibility for the discount can be confirmed on Enrolment Day.

Existing members who did not pay a full membership fee in 2020 need to pay \$65 before enrolling in any activity for 2021.

The joining fee for new members is \$65 and should be paid before enrolling in any activity for 2021.

Members who wish to have the monthly BUZZ newsletter posted are asked to pay an additional annual fee of \$15 to cover the cost of postage. Members are reminded the BUZZ is on the website and copies can be collected from the office.

HOW TO ENROL INTO 2021 ACTIVITIES

Online enrolment via U-MAS for Members on the U3A Bendigo website commences at 10:00 am on Wednesday 27 January 2021.

For members wishing to enrol in person, U3A Bendigo is holding two Enrolment Days in 2021 to help reduce congestion and limit the number of people entering the building at any one time.

Members re-enrolling in activities can do so at St Mary's Hall from 10:00 am on Wednesday 27 January 2021 until 2:00 pm.

New members and those existing members who couldn't make 27 January are encouraged to enrol in person from 10:00 am on Thursday 28 January 2021 until 2pm at St Mary's Hall.

All members enrolling in person will need to enter through St Mary's church door and leave by the hall door. This will help with the flow of people.

All renewing and new members will need to complete a Renewal or New Member form and an Activity Sheet, so they can be enrolled into the activities of choice.

Membership Application forms and Activity Enrolment Sheets will be available at the door. They can also be downloaded from the website and completed before coming to the Enrolment Day. This will help to save time.

Payments will be taken in the Hall and must be accompanied by a completed Membership Application Form and an Activity Enrolment Sheet, so members can be allocated to Activities correctly.

Preferred payment is through your Bank online, as outlined on the Membership forms. Members can also use their card or pay by cash or cheque on Enrolment Day.

Members are reminded they will be required to wear a fitted face mask in the Hall.

Members are asked not linger on Enrolment Days.
